"Major:" demolition or relocation of a building, structure, or part thereof, or which involves an addition of building space to a building or structure; or any grading, land disturbance, and/or paving or improvement for additional parking involving five or more parking spaces or 2,000 square feet or more of area.

"Minor:" All signs; any other material change in appearance not meeting definition of "major." Major applications require a public hearing by the Historic Preservation Commission and written notice to abutting property owners in addition to the sign and newspaper notice.

"Complete application:" Typically includes: application form, elevation drawings, color and material samples, photographs of structures on adjoining properties, site plan, and landscaping plan, fee (must be paid at time of application – the application fee is nonrefundable). Contact zoning administrator for additional information. Submit all materials in hard copy; e-mailed applications are normally not accepted.

Required fees: Minor: \$70.00. Major: \$275.00. Exemption letter: \$25.00. (Reference Resolution 19-17). Make checks payable to "City of Jefferson." The city may take credit card payment by phone: 706-367-5011 ext. 1. Visa and Master Card are accepted.
