

EFFECTIVE MARCH 1, 2018

The City of Jefferson City Council has adopted by ordinance water and sewer rate schedules and changes to policy. Below are a some of the changes. WATER LEAK POLICY CHANGE

In order to promote good water stewardship by its customers, adjustments for water leaks shall only be granted for documented water service leaks that occur between the water meter and the customer's structure. Leak adjustments will not be granted for leaks associated with internal plumbing and plumbing fixtures, i.e. toilets, washing machines, dish washers, refrigerators, water heaters, etc. Any leak adjustment shall not exceed \$75.00 per calendar year. Irrigation system leaks do not qualify for leak adjustments.

All leak repairs must be documented with repair bill and photographs.

A leak adjustment will only be given for one billing cycle. The cost for any water leak lasting greater than one billing cycle shall be the responsibility of the customer.

Water Meter and Box Damage Schedule

Replacement of meter	\$350.00
Replacement of meter box	\$200.00
Replacement of setter	\$300.00

Replacement of inside / outside piping	\$100.00
Raise or lower meter box	\$100.00
Relocate meter box	\$650.00
Uncover meter box	\$ 50.00
Reinstall meter	\$200.00

Water Service Tampering and Theft

Offense	Charge
Tampering Fee – First Offense	\$250.00
Tampering Fee – Second Offense	\$500.00

Policy Changes

Nonpayment within 45 days from the billing date will result in the water being shut off from the water user's property.

Water and sewer service shall not be reconnected until the customer's delinquent bill, including penalty and disconnection charges, have been paid in full. Service will not be restored until the **FOLLOWING BUSINESS DAY.** Should such customer thereafter desire to be reconnected to the water and sewer system, a reconnection charge as set forth in the fee schedule adopted by resolution of the city council pursuant to Sec.54-56 shall be collected.

Sewer Customer Charges

- Charges to flush and unstop a service lateral
 - o \$150.00 for the first two-hours. \$50.00 per hour thereafter.

Charges will be invoiced upon completion of work. If it is determined that a blockage was the result of problems with the City's sewerage system, no charges will be assessed.

- Charges to TV a sewer service
 - o \$150.00 for the first two-hours. \$50.00 per hour thereafter.
 - O Additional \$50.00 to provide a digital copy.
